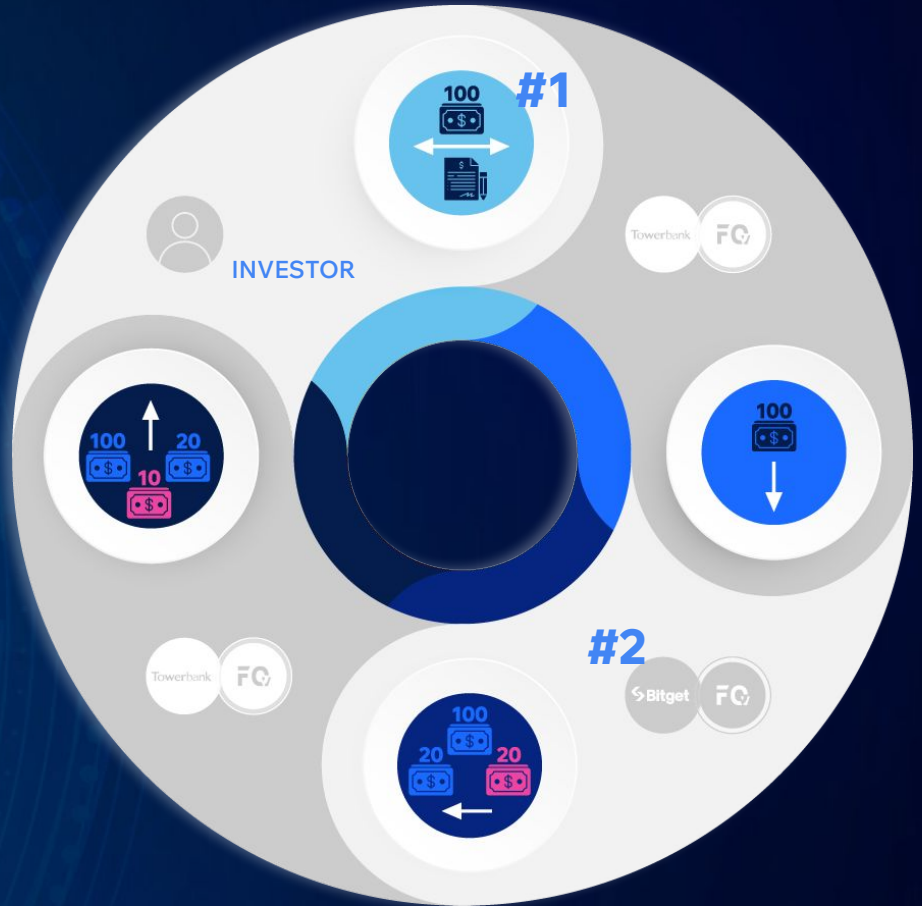
Our partners

Institutional grade HFT infrastructure: At FORMATNULL an individual investor's budget is deployed into the same infrastructure as eight-figure institutional capital.

All trading infrastructure and software are developed in-house and fully owned by FORMATNULL ventures, with redundancy implemented across every technological layer.

Proprietary algorithms undergo rigorous staging and backtesting before being deployed in live trading environments.

Exclusive agreements with major exchanges and provide enhanced protection against potential exchange failures, along with priority support in the event of unforeseen circumstances.

SECURITY | Operating under regulatory oversight with external third-party audits

F0v is proud to announce its partnership with CV5 capital, a Caymans based, global fund-launch platform that provides the backend infrastructure for hedge funds and crypto investment funds.

Under CV5's oversight, FORMATNULL ventures operates as a licenced crypto hedge fund out of the Cayman islands, with CIMA-regulation, 3rd party auditing and government reporting requirements.
